Elbert County Library District (dba Pines & Plains Libraries) Board of Trustees Minutes October 25, 2023

The Board of Trustees of the Pines & Plains Libraries met for a regularly scheduled meeting at the Elbert Library.

- 1. <u>Call Meeting to Order</u>: The meeting was called to order at 6:01 p.m. by Robert Thomasson.
- <u>Roll Call and Verification of Quorum</u>: Board Members present: Robert Thomasson, Alan Krenek, Sheila Zuschek, and RuthAnn Stricker. Staff Present: Director Susan Byrne, Branch Manager Laurie Van Court, Administrative Assistant Nat Nelson.
- Acceptance of the Agenda: *Motion to approve the agenda.* Alan Krenek motioned; Sheila Zuschek 2nd All approve.
- 4. Consent Agenda:
 - a. <u>September 27, 2023 Minutes</u>: Minutes reviewed, no comments
 - b. <u>Correspondence</u>: None
 - c. <u>September Bank Reconciliation</u>: Alan Krenek provided the Board with a comprehensive review of the District funds status:

Community Bank of Colorado checking account starting balance of \$901,519.41, checks and payments of 23 items at \$141,959.39 and credits and deposits of 4 items at \$24,565.37 making the ending balance \$784,125.39.

Community Bank of Colorado payroll account starting balance of \$140,974.07, checks and payments of 9 items at \$56,685.50 and credits and deposits of 1 item at \$126,000.00 making the ending balance \$210,288.57.

Community Bank of Colorado Money Market account starting balance of \$705,809.99, interest deposit of \$1,595.32 making the ending balance \$707,405.31.

The BMO Money Market account starting balance of \$717,602.74, interest deposit of \$1,239.62 making the ending balance \$718,842.36.

 - a. Community Needs Assessment Committee: The Board received a report from Anders Dahlgren about his visit to the libraries of the Pines & Plains Library District during the September Board of Trustees meeting. Robert Thomasson has been corresponding with Mr. Dahlgren throughout the month. The Board study session on November 1st has been canceled.
- 6. Director's Report:
 - a. Staffing Update: Laurie Paiga Lopp started as the new Library Service Tech Lead on October 2nd. Several subs have been taken off of the payroll. Two new subs are starting in Simla. The new Branch Manager for Kiowa and Elbert will be starting November 6th.
 - b. Circulation Statistics: Circulation stats are up from 2022.
 - c. Facilities: The Elbert Library was closed on October 12th as the employee who runs it was sick and no substitute was available. Staff at Elizabeth are being spoken to about making sure that the door from the meeting room to the back office area is kept locked. The Friends of the Library had the new back door at Kiowa installed on October 11th, with the screen door to be installed soon. The company that purchased the house next to the Kiowa Library has removed two trees from their backyard. The boiler at Kiowa had a problem that left the library without heat from October 13th through October 19th when the boiler was fixed. The Simla Library has been without internet for a few days, a work order has been placed with the ISP company. Simla closed 25 minutes early on October 10th due to an Xcel Energy meeting.
 - d. Time Off: Director Byrne will be out a few days during Thanksgiving.
